This could be on a rotation type basis if needed.



We have been working on the day-to-day items that our facility has. Many of the items are being done by volunteers who noticed things that need attention. We are grateful for your help with these things.

Our latest work is focused on the education wing renovation project which is to go through and decide what to keep and what to donate or trash. This is a challenge because we have collected a lot of Christian education materials. After we paint and replace the flooring in the larger classroom, we will be going through the materials to equip that room. We will be doing the same thing for the other rooms as well. When all the rooms are completed, we will go through the left over items to see what to donate and what to discard. We will give you an opportunity to help with that so you can see if you want any of these items.

We will be doing a facility assessment in March for the upcoming years to identify the needs that are most urgent. We will use this information to help us with getting some new insurance quotes to see if we can reduce our premium.
